A RESOLUTION OF THE BOARD OF TRUSTEES OF STEVENS COUNTY RURAL LIBRARY DISTRICT, STEVENS COUNTY, WASHINGTON, ESTABLISHING A FORM OF REIMBURSEMENT

STEVENS COUNTY RURAL LIBRARY DISTRICT Loon Lake, Washington

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF STEVENS COUNTY RURAL LIBRARY DISTRICT, STEVENS COUNTY, WASHINGTON, as follows:

WHEREAS, the Stevens County Rural Library District, Stevens County, Washington (the "District"), is a rural county library district duly organized and existing under an by virtue of the Constitution and laws of the state of Washington;

WHEREAS, the District was organized as a rural library district to provide library services within its boundaries and over time the District has expanded its service throughout its boundaries;

WHEREAS, the District now has an opportunity to expand its services by acquiring the Chewelah Library in the City of Chewelah, Washington (the "City");

WHEREAS, District has purchased the Chewelah Library from the City, and plans to finance such purchase with the Washington State Office of the Treasurer;

WHEREAS, the District has obtained investments from its reserves with Stevens County, Washington, to make the purchase before closing the transaction with the State Treasurer; and

WHEREAS, the District shall reimburse itself for the funds used to purchase the library upon the closing of the financing with the Washington State Office of the Treasurer.

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED as follows:

- **Section 1.** The Stevens County Rural Library District (the "District" or "Local Agency") reasonably expects to reimburse the expenditures described herein with the proceeds of a financing contract to be entered into by the Local Agency (the "Reimbursement Obligation").
- **Section 2.** The expenditures with respect to which the Local Agency reasonably expects to be reimbursed from the proceeds of Reimbursement Obligations are for a building at 307 East Clay, Chewelah, WA 99109, supplying Library Services to Stevens County.
- Section 3. The expenditures with respect to which the Local Agency reasonably expects to be reimbursed from the proceeds of Reimbursement Obligations will be made from the Revenue and Investment Pool of the Stevens County Rural Library District.

Section 4. The maximum principal amount of Reimbursement Obligations expected to be issued for the property described in Section 2 is \$215,000.00.

Section 5. All resolutions or parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed, and shall have no further force or effect.

Section 6. This resolution shall be in full force and effect from and after its adoption.
