A RESOLUTION OF THE BOARD OF TRUSTEES OF STEVENS COUNTY RURAL LIBRARY DISTRICT, STEVENS COUNTY, WASHINGTON, ADOPTING THE 2023 GENERAL OPERATING FUND BUDGET; CERTIFYING TO THE BOARD OF COUNTY COMMISSIONERS OF STEVENS COUNTY THE DISTRICT'S 2023 GENERAL OPERATING FUND BUDGET;

Whereas the Honorable Board of Commissioners of Stevens County, Washington are hereby requested to make a levy for 2022 for 2023 taxes for the Stevens County Rural Library District in the amount of \$1,622,881;

Whereas the Treasurer of Stevens County, Washington, is hereby authorized and directed to collect and deposit the monies received from the collection of the tax levy, specified above in the amounts and funds as specified below:

#### \$1,622,881 - Expense Fund of the Stevens County Rural Library District

Now, therefore be it resolved that the Board of Trustees do adopt the following 2023 Budget with Revenues totaling \$2,012,082 Expenditures totaling \$2,012,082, with an estimated undesignated, unrestricted fund balance of \$822,975 (as of 11/8/22) and that one copy of this resolution together with Exhibit A be delivered to the Stevens County Board of Commissioners and the Stevens County Auditor.
